Our Capital Budget Ask of \$300,000.00 to replace Imagination Station was approved by the Ohio House of Representatives and recommended to the Ohio Senate for their approval when they return to session at the direction of the President of the Senate

Once approved, our request will be assigned to a State Department for disbursement and the guidelines for expenditures will be provided to us at that time.
